

# Special Master Renders Decision On Wilton Manors Contract

ontract negotiations ✓between the City of Wilton Manors and the Broward PBA began on May 17, 2005, and ended September 23, 2005. Impasse was declared by the PBA after six bargaining sessions. In prehearing sessions, the City listed ten impasse issues and the PBA listed two. At the inception of the impasse hearing, the parties narrowed the list of issues for resolution by the Special Master by indicating their agreement on five issues.

There were five issues remaining subject to the

recommendations of the Special Master. On the article concerning PBA Business, the Special Master agreed with the PBA that the present article be continued. Both parties had agreed on the first year wage increase of 3%, which the Special Master recommended including retroactivity to October 1, 2005.

In reference to take home vehicles, the PBA's proposed article was recommended. The Special Master sided with the City to continue with a 3% multiplier in the pension. The Special Master further recommended that the previously negotiated 3% pension COLA be continued without the sunset provision.



# Rumor Control

Do marked police vehicles have to pay tolls?

That depends. Section 338.155, Florida Statues states:

"Any law enforcement officer operating a marked official vehicle is exempt from toll payment when on official law enforcement business."

The caveat: Your agency must approve it. Some departments do, others don't. BSO, for example, does not.

# Use of PBA Emblems

Who is allowed to display the PBA emblem? According to Florida State Statue 817.311, "any person who shall wear or display a badge, button,

insignia or other emblem, or shall use the name of or claim to be a member of any benevolent, fraternal, social, humane or charitable organization, which organization is entitled to the exclusive use of such badge, button insignia or emblem either in the identical form or in such near resemblance thereto as to be a colorable imitation thereof, unless such person is entitled to do so under the laws, rules and regulations of such organization, shall be guilty of a misdemeanor of the first degree."

The Broward County PBA's policy has always been that any member, member's immediate family, honorary member or retired member is entitled to display our emblem.

Florida's Uniform Traffic Control law states that nothing shall be placed upon the face of a Florida license plate except as permitted by law or by rule or regulation of a government agency. There are no exceptions, even for police organizations. The bottom line is: Use common sense. If you are stopped and issued a written warning and told to remove your PBA emblem, do it. You can always pick up another if you are entitled to have it.

### Retiree Health Insurance Subsidy Approved By Florida House Committee

The Health Insurance Subsidy increase Bill (HB 105), sponsored by Representative Bob Allen, was approved by the House Government Operations Committee on January 25.

Should the bill be passed, state and county employees can expect to see an increase in their monthly retiree health insurance payment. The current system gives each retiree \$5.00 per month for every year of state of county employment (for 25 years in Special Risk, you receive a check for \$125 each month). The new bill will increase the payment to \$7.00 per year of service with an increase of up to \$250 per month.

## Maine Proposes To Exempt Pension Income From Taxation

The governor of Maine has a plan to exempt military pensions from state income taxes in an effort to attract retirees who have high work skills and few needs for government services. The exemption would apply to all of those in the military who retire after January 1, 2007.

More and more states are offering tax breaks on pension income. Twelve states now exempt military pensions from state income taxes: Alabama, Hawaii, Illinois, Kansas, Louisiana, Massachusetts, Michigan, Mississippi, New Jersey, New York, Pennsylvania and Wisconsin. Nine states have no personal income tax: Alaska, Florida, Nevada, South Dakota, Texas, Washington and Wyoming. The states of New Hampshire and Tennessee collect income taxes only on interest and dividend income.

# Death Benefits for Florida Law Enforcement DROP Participants

The Florida Retirement System provides for inthe-line-of-duty death benefits with the exception of DROP participants. The language excepting DROP was added by the Florida legislature when the program was initiated. But Section 112.19, Florida Statutes also provides death benefits for law enforcement, correctional and correctional probation officers.

The payments are in addition to any workers' compensation or pension benefits and are exempt from the claims of creditors. Unlike FRS, Section 112.19 does not contain an exclusion for DROP participants. Section 112.0981(3)(b)3 provides that participation in the DROP does not alter a participant's employment status and such employee shall not be deemed retired from employment until his or her deferred resignation is effective and termination occurs. Thus, death benefits provided in Section 112.19 are available to law enforcement, correctional or correctional probation officers who are DROP participants.

# New York Senate Approves Bill To Raise Earnings Cap For Government Pensioners

Retirees from state and local government can earn more money without paying a pension penalty under legislation recently approved by the New York State Senate. The bill extends from \$27,000 to \$30,000 the amount seniors can make per year without paying penalties on their pensions. The provision would go into effect in 2007. The bill now awaits action by the State Assembly.

# Health Bytes





#### **Exercise Heals**

Older adults who were regular exercisers experienced faster healing of wounds than their sedentary counterparts. A recent study found that the wounds of the exercisers healed up to 10 days faster.

Exercise may speed healing by enhancing neuroendocrine function. Healthy people should aim to get at least 30 minutes of physical activity on most days to get the greatest health benefit. Those with serious wounds, injuries or surgeries should only engage in exercise with a doctor's permission.

### Snack Your Way To Lower Blood Pressure

A diet with ample amounts of vegetable protein, like that found in sunflower seeds, may help control blood pressure. A diet high in animal protein offered no such benefit in a recent study. Sunflower seeds, cashew and kidney beans are all high in pressure-lowering veggie protein.

Vegetable-rich diets may also help reduce the risk of obesity, heart disease, diabetes and certain types of cancer. Exercising regularly, reducing stress and limiting salt intake (if you are salt-sensitive) will help you get a handle on your blood pressure as well.

#### Another Reason To Turn Off The TV

Watching too much television has been associated with higher rates of depression in women, according to a recent study. The results, however, were not the same for men. Spending less time engaging in sedentary behaviors and more time engaging in physical activity is a great mood booster.

Exercise releases endorphins, feel-good chemicals that your body produces naturally. Most people would probably benefit from cutting their TV viewing down to no more than two hours a day and replacing it with something more active.

### **Stop Storing Fat**

The best thing you can do to lose weight or to avioid gaining it: cut down on sugar. Eating sugar causes your body to store fat.

Sugar can be found in the most unlikely of places, like in refined carbs like bread, rice and pasta. It's even in beer and milk. Your body can't tell the difference between these sugars and plain sugar - it absorbs all these as glucose.

Every time you eat sugar, your blood glucose level rises quickly, releasing insulin, which signals your body to store fat. The more sugar you

consume at one time, the higher your blood glucose rises and the longer you stay in fat-storage mode.

In order to short-circuit this, there are some things you can do to keep your blood sugar from spiking:

Add some vinegar to your diet. In a study, vinegar consumed along with a meal resulted in 23 percent lower blood glucose than without it. Try some vinaigrette on your salad.

Get some fiber. Taking 1.2 g of glucomannan - a soluble fiber made from the Japanese kinjac root - thirty minutes before eating led to a 28 percent reduction in blood glucose.

Get your caffeine, but without the sugar. Caffeine increases the rate at which your body burns fat - as long as it's not paired with sugar. So skip the the doughnut, muffin or bagel with your morning java.

Add some metal. Take 400 micrograms of chromium picolinate before a high-carb meal and it could mean 23 percent lower blood glucose levels than without it.

Work out in the morning. A single workout session can reduce the effect of a high-sugar meal on blood gulcose by 15 percent for more than 12 hours after the workout.

# A Letter From The Vice-President

ear Members,

I recently watched the news story "Police Station Intimidation" on CBS4 and was completely disgusted. For those of you who have not seen the story, reporter Mike Kirsch teamed up with The Police Abuse Center (PoliceAbuse.org) to allegedly

ascertain if police departments in South Florida provide complaint forms to citizens. Additionally, they conducted a racial profiling test on the Broward Sheriff's Office.

Basically, CBS4 sent an individual into police stations to inquire as to the method of filing a complaint. Once the sergeant began to ask appropriate questions in order to properly deal with the complaint, the complainant would refused to answer and ask for a complaint form. Subsequent to the sergeant advising that there was not a form, he would again, attempt to deal with the complaint, with a complete lack of cooperation from the complainant. It goes down hill from there.

You might be asking yourself, why Mike Kirsch's story is titled "Police Station Intimidation" when he was simply attempting to find out how many police departments provide citizen complaint forms. Moreover, why is Mike Kirsch taking police officers/supervisors from their official duties to deal with bogus complaints. After viewing the story, the answer is obvious, he had an agenda. For those of you who do not know, this is not the first time Mike Kirsch has done a "hatchet job" on law enforcement.

Generally speaking, what Mike Kirsch calls police station intimidation was nothing more than frustration felt by the supervisors who were legitimately attempting to deal with a complaint from an uncooperative complainant. Furthermore, it was so clear that much of videos were cut and edited.

I can certainly understand an unedited news story wherein supervisors refuse to take complaints, and in essence, kick people out of the building. However, this was not the case. On CBS4's Web site, Mike Kirsch's profile states that he wants to be a journalist "To learn. To share. To record history." Yet his recent track record, as it relates to law enforcement, does not live up to those words.

If CBS4 truly wants a great story, they should introduce Al Sunshine to Mike Kirsch. Al Sunshine could have a field day investigating Mike Kirsch's reports. The only problem would be Al's redundant, although necessary, repeating of "Shame on you."

Celebrate with a traditional Irish breakfast

## Irish Breakfast

#### **Ingredients**

1 lb Irish bacon 1 lb Irish pork sausages 2 to 4 tomatoes

1 / 2 lb white pudding 1/2 lb black pudding

1 dozen eggs

1 lb mushrooms - optional Serve with soda bread and/or toast.

#### **Method**

Depending on how many guests you're having, enlist the aid of someone to set the table, fix the

toast, and brew the coffee and tea.

Meanwhile, follow the cooking instructions that come with the imported Irish bacon, sausages, white pudding and black pudding.

When the meats are cooked, put them on an oven-proof serving platter and place in a slow oven to keep warm. Sauté the mushrooms and tomatoes and place them on the meat platter. Eggs are the last to be cooked and we usually make it easy on ourselves by fixing them sunny side up for

# The Living Will and Health Care Surrogate

Two documents every police officer needs

As many as 75 percent of adults in this country have not specified how they would like to be cared for in the event they become incapacitated and can't make decisions for themselves.<sup>1</sup>

# **Living Wills: A Primary Advance Directive**

At any age, illness or injury can cause a catastrophic medical condition resulting in the loss of an individual's ability to make decisions. A living will is considered an advance directive, meaning that people can provide instructions for their own medical care and other treatment in advance of such circumstances.

A living will allows a person to specify what should be done or should not be done in the case of a seemingly irreversible coma or a terminal medical condition. Doctors and hospitals can be instructed whether or not lifesustaining procedures are desired. With a living will in place, any verbal expression of wishes that were made prior to the execution of the document will not have the same legal effect.

#### Healthcare Proxy: Assigning a Healthcare Surrogate

Another common directive is a healthcare proxy, also known as a healthcare

power of attorney or surrogate healthcare designation. This directive names a person (an "agent") to act on behalf of someone else (the "principal") if that person is unable to make medical decisions.

The optimal approach is to name the person who is best suited for the task, regardless of marital or familial ties. Ideally, a



healthcare agent should be attuned to the principal's desires and be able to live with the consequences of difficult life-anddeath decisions.

Generally speaking, individuals should have as a minimum both a living will and a healthcare proxy. This is important because typically a living will does not grant authority to specified person(s) to make decisions in accordance with the terms of a living will. Also, some states do not permit the person holding the healthcare proxy to make decisions regarding artificial nutrition and hydration without the prior

instructions of the patient on this matter. Such instructions could be provided though a living will.

# Law Enforcement News

Items of Interest From Around The U.S.

A recent poll conducted by Zogby International shows that the majority of Americans believe that the main purpose of prison is punishment, not treatment. The poll also showed that 85 percent of responders favor mandatory sentencing for first-time offenders and 95 percent want mandatory sentencing for repeat offenders.

Three-fifths of those polled believed that chronic sex offenders cannot be cured. The poll was conducted in response to a Vermont judge's sentencing of a chronic sex offender to six months in prison in protest to the state's refusal to provide treatment until after his prison sentence was served.

Montana – The Associated Press has discovered that hundreds of people barred from having guns because they are felons on parole or probation are still able to get Montana hunting licenses with no questions asked.

Only a handful of states ban felons from receiving hunting permits and only a few others require hunters to show both a hunting license and a firearms license.

AP's investigation found that at least 660 felons on parole or probation received hunting tags in the past year. The licenses don't specifically require the use of firearms to hunt, and state officials note that most felons could legally hunt using other weapons. But some of the game for which felons were issued

tags, such as birds or bison, require the use of guns.

With millions of hunters in the U.S., authorities in many states say it simply would be too difficult to check if felons are getting hunting tags.

#### U.S./Mexican Border -

Investigators uncovered a sophisticated cross-border tunnel that was used to traffic marijuana into the United States. Found in the tunnel were two tons of pot.

The tunnel begins about 85 feet below a small warehouse about 175 yards south of the U.S. border. The tunnel is about 2,400 feet long, or about the length of eight football fields. It has sophisticated lighting and ventilation systems and possibly a pumping system to pump ground water.

The elaborate tunnel bears the hallmarks of Mexican drug cartels, according to authorities. A total of four tunnels were discovered over the course of a month.

### Macomb County, Mich. -

The NAACP has accused police in Macomb County of using pillowcases to "hood" handcuffed suspects. Law enforcement officials contend that there is no proof it ever happened.

The NAACP has requested the FBI investigate an alleged hooding that occurred when sheriff's deputies and Chesterfield Township police raided a home during a drug search in late 2005 and hooded a black couple with their pillowcases after they were handcuffed.

Two other incidents have been discussed with the FBI as well. Macomb County Sheriff Mark Hackel believes this to be a politically motivated attack.

**Miami** – The United States Drug Enforcement Agency have charged 30 people with smuggling illegal drugs after finding packets of liquid heroin surgically implanted in the stomachs of purebred puppies.

The DEA said the traffickers were attempting to smuggle the dogs into the U.S. on commercial flights. The heroin was to be distributed along the East Coast.

During a raid, officers found six puppies impregnated with the packets. Three of the dogs later died from infection after the drugs were removed. Officials say the group also used human couriers, aerosol cans and body cream containers to transport the heroin.

Channel 4's "Investigative Report," "Police Station Intimidation," claimed that filling complaints with police departments throughout Broward County could be a serious problem.

This news report was a slanted and fabricated piece of trash, and should be in the tabloids rather than on a legitimate news program

What the piece fails to show the audience is the "complainant's" comments and demeanor during the proceeding 10 to 30 minutes where the "complainant" creates a confrontation or appears to he a possible mental patient.
