This First Amendment is entered into this 8 day of October, 2013, by and between the Broward Sheriff's Office (hereinafter referred to as "BSO") and the City of North Lauderdale (hereinafter referred to as the "CITY").

WHEREAS, on or about September 14, 2011, BSO and the CITY entered into an Agreement for Police Services; and

WHEREAS, BSO and the CITY are now desirous of decreasing staffing by one (1) Lieutenant and one (1) Community Service Aide, and modifying the consideration accordingly; and

NOW, THEREFORE, in consideration of the mutual terms and conditions contained herein, the parties agree as follows:

3. 1. Section ___ of the Agreement for Police Services is amended to reflect that commencing on October 1, 2013, the staffing structure shall be decreased by one (1) Lieutenant and one (1) Community Service Aide, and the consideration decreased accordingly, resulting in a Revised Exhibit A, which is attached and incorporated herein.
4. 2. Exhibit "A" to the Agreement for Police Services, entitled "Special Terms and Conditions" is replaced in its entire with the "Revised Exhibit A," attached hereto.
3. Except as otherwise modified herein, the terms and conditions of the Agreement for Police Services shall remain in full force and effect.
